HAIRCUT

- The haircut must respect the client's wish
- The look is fashion inspired not OMC or avant-garde
- All cutting techniques and tools are allowed.

COLOUR

- Fashion colour not avant-garde or extreme
- All colouring techniques are allowed to enhance the finished design
- All colour products are allowed to be used in this module with the exception of coloured sprays (including glitter), coloured mousse, coloured gels, coloured markers, crayons etc. cannot be used.
- Colour must respect the client's wish

FINISH RESULT

- The finish style must respect the client's wish
- All styling products and tools are allowed

Test 2 - BRIDAL LONG HAIR WITH WISHES

TIME

1hour 45 minutes

RATIONALE

The Competitors will have to create trend fashion bridal look that should be commercial and not OMC or avant-garde. The look should respect the client's wishes. The wishes must be the main element of the final look.

COLOUR

• In this module, you are not allowed to use any colour or neutralizing shampoo

FINISHED RESULT

- The finish result must respect the client's wishes
- All styling tools are allowed
- Cutting tools are not allowed
- Ornements or veil are not allowed, only the one that could be provided by Skills Canada are allowed
- Hair fillers, padding or hair nets are not allowed
- Coloured sprays (including glitter), coloured mousse, coloured gels, coloured markers, crayons etc. are not allowed
- Dressing of the mannequin is not allowed
- The finished result must be worn by a bride on her special day
- The finished result should not cover the eyes

Test 3 - LADIES FASHION WITH WISHES

TIME

3hours

RATIONALE

The competitors will have to create fashion ladies trend for our more adventurous client but not OMC or avant-garde from the client's wishes. The wishes must be the main element of the final look.

HAIRCUT

- All cutting tools are allowed
- Must respect client's wish

COLOUR

- All hair must be colored
- Must respect client's wish
- All colour techniques are allowed
- Colour must be fashion trend, not funky avant-garde.

Note: Competitors must bring a palette of colour choices to allow for any combination.

FINISHED STYLE

- All tools are allowed.
- All styling products are allowed
- Coloured sprays (including glitter), coloured mousse, coloured gels, coloured markers, crayons etc. are not allowed
- The finished style can cover one eye if needed.
- Must respect the client's wish

Test 4 – MEN'S HAIRCUT AND STYLE WITH PHOTO

1hours 30 minutes

RATIONALE

The competitors will have to reproduce as close as possible the men's haircut and style showed on the photo. Hair colour must not be changed.

HAIRCUT

- The cut must be a reproduction of what you see on the photo
- All cutting tools are allowed except clippers (any electrical or battery) and tweezers.

FINISHED STYLE

- Only hand-held dryer may be used
- Pan is forbidden
- No thermal irons allowed
- Brushes and/or combs and clips are allowed
- All styling products are allowed
- Coloured sprays, coloured mousse, coloured gels, coloured markers, crayons etc. are not allowed
- The finished result must be a reproduction of the photo
