I acknowledge and accept that in order to be eligible to participate in certain of the activities offered at the SCNC, as determined by Skills/Compétences Canada at its sole discretion (collectively, the “Activities”), including, without limitation, the “Try-A-Trade and Technology” activities, I must first sign and return this Agreement as instructed;
3. I acknowledge and accept that participation in the Activities (and, if applicable, the use of certain instruments/tools as required to participate in certain Activities) involve a degree of inherent risk, including, without limitation, risk of physical injury, and I agree to personally accept any and all such risk;
4. I permit Skills/Compétences Canada and others working for or on its behalf to film and/or take photographs of me participating in the SCNC (collectively, the “Footage”), including, without limitation, participating in the Activities;
5. I give my permission, irrevocably and in perpetuity, to the Released Parties to reproduce, copy, publish, broadcast, or otherwise use my name, likeness, image, voice, appearance, performance and statements (collectively, my “Likeness”) as they appear in the Footage (as may be retouched, edited, mixed or duplicated) and any material based upon or derived therefrom (collectively, the “Product”) in any manner or media whatsoever (now known or hereafter developed), including, without limitation, for any and all advertising, promotion and/or other purposes of trade;

I release and forever discharge the Released Parties from any liability, including, without limitation, all actions, causes of action, suits, debts, liabilities, claims and demands of any nature, in connection with the SCNC and my participation therein, including, without limitation, my participation in any of the Activities, any Footage taken of me participating in the SCNC or arising out of the exploitation of the Product;

I grant Skills/Compétences Canada, worldwide and in perpetuity, all right, title, and interest of every kind in and to the Product, including, without limitation, copyright and performance rights, and acknowledge that I have no interest or ownership in the Product or its copyright and I agree to execute any such further documentation to evidence such grant of rights, title and interest (as determined by the Released Parties at their sole discretion). Further, to the extent that I may have any moral rights in the Product, I hereby waive all such moral rights in favour of the Released Parties;

I acknowledge that the Released Parties’ decision to use my Likeness as set out herein is at their sole and absolute discretion and agree that I shall have no right of approval, no claim to additional compensation or benefit, and no claim (including, without limitation, claims based upon invasion of privacy, defamation, or right of publicity) arising out of the use of my Likeness by the Released Parties; and
9. I confirm that I have the right to enter into this Agreement and that the Released Parties have no financial commitments and obligations to me as a result of this Agreement and I warrant and represent that I am not a member of any type of talent guild or union.
