1 THE SKILLS FOR SUCCESS FOR CAREERS IN THE SKILLED TRADES AND TECHNOLOGY

In response to the evolving labour market and changing skill needs, the Government of Canada has launched the new Skills for Success (former Essential Skills) model defining nine key skills needed by Canadians to participate in work, in education and training, and in modern society more broadly. SCC is currently working with Employment and Social Development Canada (ESDC) to bring awareness of the importance of these skills that are absolutely crucial for success in Trade and Technology careers. Part of this ongoing initiative requires the integration and identification of the Skills for Success in contest descriptions, projects, and project documents. The next phase and very important aspect of our Skills for Success (SfS) initiative is to provide a Skills Report Card to each competitor at the Skills Canada National Competition. The purpose of the report card is to inform the competitor about their current level of nine identified Skills for Success based on their competition scores. With this knowledge, the competitor will be made aware which skill may require improvement. Full implementation is expected in the next Skills Canada National Competition.

The following 9 skills have been identified and validated as key skills for success for the workplace in the legend below:

¹Numeracy, ²Communication, ³Collaboration, ⁴Adaptability, ⁵Reading, ⁶Writing, ⁷Problem Solving, ⁸Creativity and Innovation, ⁹Digital

2 CONTEST INTRODUCTION

2.2 Purpose of the Challenge

The principal function of an aesthetician is to give beauty care to persons with the main purpose of improving their appearance as well as giving the people a physical and psychological well-being. By general means, the essential part of this work is to trat different parts of the body including specific care to facial skin, specific care for the hands, specific care for the body, and the application of makeup, while demonstrating professionalism and complying with occupational health and safety.

2.4 Skills and Knowledge to be tested.

Mini Facial & Bridal Makeup – The competitor will apply a mini facial followed by a bridal makeup. The bridal makeup will include foundation with corrective work, blush, blended eye shadows, eye liner, and red lipstick. The competitor will then demonstrate a mini facial using the sponsor's products (DERMALOGICA.) ^{2,8}

Manicure with Nail Art (permanent polish) - The competitor will demonstrate a manicure using the sponsor's products and will duplicate the nail art. This is done with a permanent polish and corrections are allowed. The LED lamp will be provided. ^{2,4,8}

Body Therapy Treatment – The competitor will demonstrate knowledge and understanding of hair removal of the underarm using hard wax including a demonstration of proper tweezing technique. It will then be followed by a body treatment including cleansing and exfoliation of the back, a hot stone massage performed on the back, back or legs and back of arms. ^{2,4}

Creative Makeup – The competitor will demonstrate a creative makeup look with a Shanghai theme. The creative makeup will include the face, neck and décolleté of the model. The Shanghai theme will be displayed on their 12x16 vision board. ^{4,8}

- **3.2** Tasks that may be performed during the contest
 - Bridal Makeup & Mini Facial:

Objectives: Perform application of bridal makeup; including foundation with corrective work blush, blended eye shadows, defined eyebrows, eye liner, and red lipstick^{4,8} followed by a mini facial. The skin must be analyzed with findings recorded on the provided analysis form and the facial must be based on that analysis.^{2,6,7}

Manicure with Nail Art:

Objectives: Perform a manicure which includes, nail shaping, cuticle work, hand exfoliation, arm and hand massage and an application of permanent polish. Nail art to be applied according to the Test Project posted on SCC website.^{5,9}
Competitors are allowed to make corrections.

NOTE – Nail art must be free hand, using only the nail art brushes and dotter supplied by the Sponsor. Decals, polish with built in striper brush, corrector pens, guideline tape, or any other tool will NOT be allowed. Nail art brushes may NOT be adjusted in any way.

- Body Therapy Treatment with Hair Removal on Underarm: Objectives: The competitor, along with the model, will verbally discuss the model release form and record findings on the provided form.^{2,3,5,6} The competitor will perform an underarm wax using hard wax (used a max of 2 times on each underarm) followed by a back cleanse and exfoliation. A 45-minute hot stone massage will be performed to the back, back of legs, and back of arms.⁷
- Creative Makeup (Shanghai themed): Objectives: Creative makeup application to the full face, neck and decollete and presentation of vision board (12x16) according to the Shanghai theme. ^{4,8}

NOTE – Decoration items (gems, glitter, headpiece, jewellery, etc) may be used after judging has taken place but will only accent the design and cannot be the focus.

4.2.1 Toolboxes Guidelines

One of the objectives of SCC is the sustainability of the Competition. As a result, the toolboxes brought by Competitors will be restricted to the following maximum specifications.

The Competitor toolbox must not exceed .506 meters³ in volume. It can be multiple toolboxes, but the total of all toolboxes must not exceed the maximum volume indicated. There is no exception to this rule. If the Competitor toolbox is larger than what is indicated, the Competitor with the guidance of the NTC, will need to remove items from the toolbox and those items will not be used during the competition. All tools must fit inside one or more toolboxes. Tools outside of a toolbox will not be permitted.

4.3 Required clothing provided by the competitor

- Uniform (see test project). NO leggings or yoga pant styles allowed. Uniform must be all black.
- Black non-slip, flat or low heel, closed toed shoes with NO laces.
- Black socks must be worn.
- No jewelry, which may interfere with the task being performed or place the model or aesthetician at risk.
- Hair must be tidy and tied back, off the collar and face.
- Competitor must have short, natural nails. No nail extensions, or recent removal of, no nail varnish or coverings.

5 HEALTH AND SAFETY

5.1 Safety program

SCC has implemented a comprehensive safety program as health and safety is an integral part of our competitions. Our safety program includes guidelines and procedures to make the work environment in each skill area safer.

5.1.1 Safety manual

As part of our program a safety manual has been created to monitor and document health and safety within each skill area. It includes a definite plan of action designed to prevent accidents. The safety manual will be provided for every skill and these instructions must be followed and respected by all participants and officials at the SCNC.

5.1.2 Safety workshop

During orientation, Competitors will participate in a Safety workshop and they will be expected to work and maintain a safe working area during the competition. Any Competitor breaking any health, safety, and environmental rules, may be required

to undertake a second safety workshop, this will not affect the Competitor's competition time.

Drawings, recording information	Nail Art project is ALLOWED at manicure station
Tools / Infrastructure	Competitors are not allowed to bring or use facial sponges

8 ADDITIONAL INFORMATION

8.1 Interpreter

If a competitor requires the help of an interpreter once onsite during the competition, the Skills/Compétences Canada Provincial/Territorial offices must advise Skills/Compétences Canada National Secretariat a minimum of 1 month prior to the competition or this service may not be guaranteed.

8.2 Ties

- **Tiebreaker #1:** In the event of a tie, the candidate with the highest score in the Bridal Makeup & Mini Facial criteria will be declared the winner.
- **Tiebreaker #2:** In the event of a second tie, the competitor with the highest score in the Body Therapy Treatment & Waxing criteria will be declared the winner.
- **Tiebreaker #3:** If a tie still remains, the competitor with the highest score in the Creative Makeup criteria will be declared the winner.
