

Test Check points and Marking Criteria

Test 1 - Chemical Texture Service, Hair Cut and Style with Wishes

Checkpoints

This test will have multiple checkpoints.

It is important to note that competitors may choose several different techniques and wrapping patterns that are all acceptable. Blend line rods may be treated differently for easier blend results and competitors must not be demerited for these artistic choices as long as they respect the health and safety of the client. The remainder of the chemically altered area should fall to manufacture instruction and industry standards.

Check point 1 (Physical Aspect)

Competitor will wrap perm and upon completion request for check point 1

- Rod selection - suitable for desired curl
- Base size - clean and suitable for placement and rod size
- Elastic placement - not creating stress on the hair.
- Even tension
- Competitor will unwrap 3 rods selected by 2 NTC to check for fishhook ends - all wraps are deemed acceptable.

Check point 2 (Chemical Aspect)

- Test curl taken - at the appropriate intervals - demonstrated to two National Technical Committee members.

Check point 3

Competitor will proceed to rinse area NTC will watch for

- Through rinse- the pressure is correct, and the chemical is rinsed for the appropriate amount of time (Authentic Practice)
- Sufficiently blot - to remove excess moisture between rinse completion and neutralization (Chemical Aspect)

- Call to 2 NTC upon color/lightener application completion – NTC will be looking at sustainability, application, staining, work area.

Check point 2

- Sink area NTC will check the sink area when competitor is complete rinsing, will check for color staining on the client at the workstation.
